PROGRAM PARTICIPANT AGREEMENT AND LIABILITY WAIVER

This Participant Agreement (“Agreement”) is entered into by and between Africa Travel Group, LLC (“ATG”) and _____ (Name of Participant) (“Participant”) concerning participation in the Liberia West Africa Fellowship Program (the “Program”).

WHEREAS

Participant acknowledges that they have received, read, and fully understand all information provided by Africa Travel Group, LLC regarding the Program, including cultural differences and safety and health risks involved. Participant and Africa Travel Group, LLC intend to be legally bound by the terms of this Agreement, including Participant’s releases and indemnity. Participant agrees as follows:

1. ASSUMPTION OF RISK

Participant acknowledges that participation in the Program is voluntary. Participant understands that Liberia may have health and safety standards different from those in the United States and may expose Participant to risks, illnesses, and injuries. Participant affirms they are mentally and physically fit and capable of participating in the Program and voluntarily assume all associated risks.

2. RELEASE OF LIABILITY

Participant hereby releases, discharges, and agrees to hold harmless Africa Travel Group, LLC, its trustees, agents, employees, representatives, and volunteers from any and all liability arising from or related to Participant’s involvement in the Program. This includes, but is not limited to, any claims related to failure to pass courses, personal injury, illness, death, property loss or damage, delays, or disruptions. This release applies even in cases of negligence by Africa Travel Group, LLC or its representatives, except in cases of fraud, willful misconduct, or violation of law.

3. PERSONAL PROPERTY

Africa Travel Group, LLC assumes no responsibility or liability for any loss, theft, or damage to Participant’s personal property during the Program. Participants are encouraged to obtain appropriate insurance coverage for their belongings.

4. CONDUCT AND DISMISSAL

Participant agrees to abide by all applicable laws, Program rules, codes of conduct, and safety guidelines. Prohibited behaviors include, but are not limited to, use of non-prescription drugs, alcohol abuse, sexual misconduct, disrespect toward host communities, and leaving the Program group without written permission. Violation of these rules may result in immediate dismissal from the Program at the Participant's sole expense, with no refund of fees.

5. OFF-HOURS AND INDEPENDENT ACTIVITIES

Participant acknowledges sole responsibility for their safety and conduct outside of scheduled Program activities or when using transportation not provided by the Program. Africa Travel Group, LLC and its partners are not liable for incidents occurring during these times.

7. FORCE MAJEURE & REFUND POLICY

Africa Travel Group, LLC shall not be held liable for cancellations, delays, or changes to the Program caused by circumstances beyond its control, including but not limited to acts of God, natural disasters, war, terrorism, civil unrest, government restrictions, pandemics (such as COVID-19), or transportation disruptions. In such cases, the Program may be canceled or postponed without penalty. Refunds, if any, will be limited to recoverable third-party costs. a) The \$500 deposit is non-refundable except if the Program is canceled entirely by Africa Travel Group, LLC. b) To request a partial refund, Participant must submit written notice of withdrawal no later than October 13, 2025 (60 days prior to the Program departure on December 12, 2025). Refunds are limited to recoverable costs from third-party providers only. c) No refunds will be issued for cancellations made within 60 days of departure or after the Program has started. d) Participants who voluntarily withdraw or are dismissed for misconduct or non-compliance will forfeit all payments made. e) Refunds are subject to third-party vendor policies. If third-party payments are non-refundable, Africa Travel Group, LLC may offer a program credit for future participation within 12 months, at its discretion. f) Participant is responsible for any cancellation fees or penalties imposed by third-party providers. By signing this Agreement, Participant agrees not to dispute payments or initiate chargebacks related to Program fees.

9. AUTHORITY TO SIGN

Participant affirms they are at least 18 years old, have legal capacity to enter this Agreement, and understand all terms including risks, waivers, and refunds described herein.

10. ENTIRE AGREEMENT AND AMENDMENTS

This Agreement constitutes the entire understanding between the Participant and Africa Travel Group, LLC. No waiver or modification shall be valid unless made in writing and signed by both parties. Africa Travel Group, LLC reserves the right to amend or update program policies, fees, and conditions in response to unforeseen circumstances, including but not limited to changes in vendor agreements, global health advisories, or government regulations. All program activities are subject to change without prior notice. Participation is voluntary, and by signing this Agreement, the Participant acknowledges and accepts all associated risks.
